Minutes of the GBM of DEVTA held on January 5' 2012

The GBM was attended by 100 plus DEVTA members on 5th Jan. 2012 at 3.30 PM in IMS auditorium. Following issues were discussed in the house and reach to consensus to bring into the notice and demand the actions on the same by University Administration

- Arrears of the due period as per 6th pay commissions' recommendations due from January' 2006 should be paid as earliest.
- Conduction of interviews for the pending cases of promotions under CAS should be done at the earliest.
- Uniform service conditions for both self finance and UGC supported faculties
- 4. Recruitment against vacant post should be as earliest as possible.
- Salary deduction of strike period must be reimburse to the teachers and the same may be adjusted by EL (as per the policy decided recently by the administration)
- Pay protection and restoration of increments gained for ME/ M. Tech. degree, which was abolished during the salary fixation as per 6th pay guidelines
- 7. Construction of at least 40 new accommodations/ flats for Teachers
- 8. Repair and maintenance of teacher's quarters
- 9. Calculation of PF / CPF should include Grade pay + AGP + DA, as per recommendation of PF commissioner rules.
- 10. Discrepancy in arrears calculations, CPF has to be considered for the same.
- 11. Discrepancy in earned leave calculation has to be resolved.
- 12. There should be no discrepancy in the quarter allotment to the teachers
- 13. Teaching posts of one department should not be transfer to other department, also Roaster Pointer Register should be maintained at both Departmental and University level

- 19. Adoption of a Group Medical Insurance Scheme for University Teachers
- 20. Safety measures in campus
- 21. There should be representative from DEVTA in quarter allotment Committee meeting.

DEVTA demand immediate action on the abovementioned issues by University administration at the earliest and also communicate to DEVTA officially
